## PROFILE

I have a thorough basic knowledge of history, literature and languages, including skills in theoretical, methodological and analytical work within these fields. The medieval period is a continued focus in my work and education, mostly in relation to legal history and Nordic literature, languages and written culture. Furthermore, I am especially focused on manuscript culture and early prints in my Ph.D. project: *Between Manuscripts and Prints – A study of the connection between handwritten and printed versions of the provincial laws of Zealand and Scania app. 1450-1650*. I have worked with editing and publication of historical text sources as a research assistant at the Faculty of Law at University of Copenhagen, alongside with production of texts for websites of medieval manuscripts at the Arnamagnæan Collection in Copenhagen. I also have experience with teaching at the University of Copenhagen and at the University of Lund, and I have held various paper and poster presentations at conferences and seminars, of which several have resulted in articles.
